# **Snow Removal Policy**

### **PURPOSE:**

To enforce a policy in regard to Snow Removal Policy.

### PROCEDURE:

The Snow Removal Policy of the Town of Hafford:

- Snow removal will not commence until the snow event is over unless roads become impassable.
- The priority shall be: South Ave to Health Care Facility,
  - Second Ave East to the Hafford School
  - Main Street
  - Railway Avenue.
- Snow shall be cleared in front of firehall, across Railway and for helicopter landing.
- Windrows are allowed but shall not block driveways and the street potion of driveway entrances shall be cleared with skid steer.
- Main street shall be windrowed to the middle and hauled away, with no snow allowed to build up next to the curbs
- No custom snow removal
- Only the alleys for the first 2 blocks of the west side of Main Street and the first block on the east side of Main Street and behind the firehall shall be cleared.
